## TWILIGHT SEMINAR FOR THE JUDICIARY

### “PEOPLE TRAFFICKING”

Monday 15 June 2009, 4.30pm  
State Library of New South Wales

The number of people trafficking cases coming before the courts in Australia is increasing. The nature of offences in which people are forced into labour, including sexual servitude, is that there are likely to be few witnesses and limited physical evidence. The credibility of victim-witnesses and their capacity to be understood can be critical to the outcome of proceedings.

These cases may be complicated by the fact that most victim-witnesses in trafficking cases:

- originate from foreign cultures
- are from low socio-economic backgrounds
- have low level English skills
- lack support networks in Australia
- experience shame resulting from public disclosure at trial of compromising conduct
- have been systematically exploited (physically, sexually, psychologically), and
- distrust law enforcement officers and the legal system.

This twilight seminar will explore the difficulties that arise for judicial officers presiding in legal proceedings in these cases. It will also look at the broader issues such as whether organised gangs are behind the ‘trade’ in people and the scope of the problem internationally.

#### Speakers

**Judge Ken Taylor AM RFD** (District Court of NSW & NSW Privacy Commissioner) presided in proceedings (*R v McIvor & Tanuchit*) in which the defendants were convicted and sentenced for multiple offences of possessing and using a slave.

**Judge Michael McInerney** (County Court of Victoria) sat in the first two trials concerning slavery offences under the Commonwealth Criminal Code. The conviction in one of the cases (*The Queen v Tang*) was subsequently upheld by the High Court.

**Dr Anne Gallagher** is the Technical Director of the Asia Regional Trafficking in Persons Project, an AusAID project that is working with national criminal justice agencies in South-East Asia to strengthen their legal, technical and institutional responses to human trafficking.

**Ms Wendy Abraham QC** has appeared as counsel in a number of people trafficking cases.
